

Terms of Use

Introduction; Your Agreement to these Terms of Use.

Welcome to the SubAzimuth web site, currently located at <http://www.subazimuth.com/>.

The following Terms of Use for the SubAzimuth web site is a legal contract between you ("You" or, collectively, "Users") and SubAzimuth regarding your use of the SubAzimuth web site.

PLEASE READ CAREFULLY THE FOLLOWING TERMS OF USE. BY ACCESSING, BROWSING, OR USING THE SUBAZIMUTH WEB SITE, YOU ACKNOWLEDGE THAT YOU HAVE READ, UNDERSTOOD, AND AGREE TO BE BOUND BY THE FOLLOWING TERMS AND CONDITIONS, INCLUDING ANY ADDITIONAL POLICIES AND FUTURE MODIFICATIONS (COLLECTIVELY, THE "TERMS"). IF AT ANY TIME YOU DO NOT AGREE TO THESE TERMS, PLEASE IMMEDIATELY TERMINATE YOUR USE OF THE SUBAZIMUTH WEB SITE.

1. Eligibility.

The SubAzimuth web site is not available to persons under the age of 18 or to any previous Users previously suspended or removed from accessing the SubAzimuth web site by SubAzimuth.

5.1 License Grant.

Subject to Your compliance with the terms and conditions set out in these Terms, SubAzimuth hereby grants to You a personal, limited, non-exclusive, non-transferable, freely revocable license to use the SubAzimuth web site for your own personal, noncommercial use.

5.2 Reservation of Rights.

SubAzimuth reserves all rights not expressly granted in these Terms.

5.3 Prevention of Unauthorized Use.

14. United States Export Controls.

We agree to comply with all export laws and restrictions and regulations of the United States Department of Commerce or other United States or other sovereign agency or authority, and not to export, or allow the export or re-export of any software, technical data or any direct product thereof in violation of any such restrictions, laws or regulations, or unless and until all required licenses and authorizations are obtained with respect to the countries specified in the applicable United States Export Administration Regulations (or any successor supplement or regulations). The transfer of certain technical data and commodities may require a license from an agency of the United States government and/or written assurances by You that You will not export such software, technical data or commodities to certain foreign countries without prior approval of such

agency. Your rights under these Terms are contingent on Your compliance with this provision.

15. Miscellaneous.

15.1 Notice.

SubAzimuth LLC may provide You with notices, including those regarding changes to SubAzimuth LLC terms and conditions, by postings on the SubAzimuth web site. You hereby consent to notice in this manner.

15.2 Waiver.

The failure of SubAzimuth LLC to exercise or enforce any right or provision of these Terms will not constitute a waiver of such right or provision. Any waiver of any provision of these Terms will be effective only if in writing and signed by SubAzimuth LLC.

15.3 Governing Law; Jurisdiction.

These Terms will be governed by and construed in accordance with the laws of the State of California, without giving effect to any principles of conflict of laws. The parties agree that the federal and state courts residing in San Francisco, California will have exclusive jurisdiction over these Terms.

15.4 No Third Party Beneficiary.

The parties specifically disavow any desire or intention to create a “third party” beneficiary contract, and specifically declare that no person, except for the parties and their permitted assigns, shall have any rights hereunder nor any right of enforcement hereof.

15.5 Severability.

If any provision of these Terms or any Policies is held to be unlawful, void, or for any reason unenforceable, then that provision will be limited or

eliminated from these Terms to the minimum extent necessary and will not affect the validity and enforceability of any remaining provisions.

15.6 Assignment.

These Terms and related Policies, and any rights and licenses granted hereunder, may not be transferred, or assigned by You, but may be assigned by SubAzimuth LLC without restriction. Any assignment attempted to be made in violation of these Terms shall be void.

15.7 Survival.

Upon termination of these Terms, any provision which, by its nature or express terms should survive, will survive such termination or expiration.

15.8 Headings.

The heading references herein are for convenience purposes only, do not constitute a part of these Terms, and will not be deemed to limit or affect any of the provisions hereof.

15.9 Entire Agreement.

This is the entire agreement between You and SubAzimuth LLC relating to the subject matter herein and will not be modified except by a change to these Terms made by SubAzimuth LLC as set forth in Section 4 above.

15.10 No Agency.

No agency, partnership, joint venture, employee-employer or franchiser-franchisee relationship is intended or created by this Agreement.

15.11 Disclosures.

PRIVACY POLICY

At SubAzimuth, we are committed to ensuring the privacy of our users. This privacy policy explains SubAzimuth's privacy practices related to SubAzimuth web site, currently located at www.subazimuth.com. Your continued use of SubAzimuth LLC's web site constitutes your agreement with this Privacy Policy and any subsequent updates.

Personal Information We Collect

You may provide personal information to us when you interact with SubAzimuth. For example, depending on the specific SubAzimuth web site page, you may provide us with personal information when you:

Contact us by email for any reason (such as to ask a question or provide us with your comments/feedback) and we collect your name and email address from this contact;

2. You are using our online request system/tool to download data sheets and product guides or to request product: or

3. Submit your resume or other personal information in response to a job opening posted on the SubAzimuth web site.

Your use of the SubAzimuth web site and submission of information indicates your consent to these uses of personal information described below. To respond to your request, this information is stored on SubAzimuth LLC servers in the United States.

How We Use Personal Information

Cookie Policy
